The following has been agreed between the breeder and "European Stallions Resort" e.a.r.l. (ESR) domiciled 1702, Chemin des Sauvagère 01960SERVAS-F and the Vet Team :

**1 : The mare and her foal :** In good condition, dewormed (strongle / tænia) for less than 15 days, vaccinated (flu, tetanus, rhinopneumonia), barefoot hind legs, shoeing in front if necessary, are entrusted with passport and the authorization to inseminate from the stallion manager (if not BLH) to ESR for his guarding and to the Vet Team for the veterinary acts. Opening hours in season: By appointment, 7 days. 7 days a week, 8 a.m. to 11:30 a.m.

**2 : Gynecological follow-up and placement of semen:** Gynecological monitoring and inseminations in frozen semen (IAC) are carried out by veterinarians, 7 days a week throughout the season. Fresh (IAF) or chilled semen (IAR) is carried out by ESR inseminators.

**3 Cost of gynecological monitoring and of insemination:** Fixed rate for the whole season (Prices including VAT 5.5%), depending on the type of semen:

- . Fresh from BLH stallion “with Wahoo conditions” ..... €300
- . Fresh or chilled from BLH stallion..... €420 with a live foal guarantee.  
The “Live Foal” Guarantee as defined by the BLH covering contract ensures that these services are free of charge the following year in the absence of a “Live Foal”.
- . Frozen semen from BLH stallion ..... €645 without alive foal guarantee.
- . Chilled semen from stallion that are not in BLH catalog ..... €530 without alive foal guarantee.
- . Frozen semen from stallion that are not in BLH catalog ..... €720 without alive foal guarantee.

. **Additional examinations and care:** To increase the chances of pregnancy, the breeder authorizes the veterinarian to perform analyzes or treatments at a cost of less than €60. For a higher cost, the veterinarian asks for his verbal agreement. The breeder authorizes the transrectal crushing of an embryonic vesicle in the event of twin gestation and knows that despite scheduled ultrasounds and to be performed around the 15th, 21st and 45th day of gestation, a twin gestation may go unnoticed (1/500).

**4 : Embryo Transfert and Ovum Pick Up for ICSI :** The breeder then concomitantly signs the “Embryo Transfer and Recipient mare Rental Agreement”.

- . Embryo flushing (8 days after ovulation) ..... €250 and Embryo implantation in a recipient mare ..... €180 per embryo
- . Frozen embryo implantation ..... €380. **For Ovum Pick Up : Please refer to “Contract for Ovum Pick Up”.**

**5 : Stable fees:** Accommodation in Stall or/and field at the stud farm or its annexes where animals are transported by van or truck

- . Mare with a foal ..... €23.3 per day (Pony : €16.8). 10% off after 30 days .
- . Mare without foal ..... €18.7 par jour (Pony : €12.7). 10% off after 30 days .

Reduction of 10% for boarding of more than 30 consecutive days in season from the 30th day. For a long-term pension by the year by ESR, refer to the ESR Agreement.

**6 : Foaling:** Arrival is expected 10 and a half months after the last insemination. Price including tax ..... € 690, including placement of the vulval magnet by the veterinarian, surveillance and foaling by ESR staff, pre and postpartum veterinary examinations, routine injections, control of passive immunity in foals . The possible supply of additional colostrum if that of the broodmare is insufficient is invoiced in addition. Any close neonatal follow-up (bottle feeding, etc.) may be invoiced in addition. Any emergency intervention by the veterinarian in the event of dystocia or during complications of foaling is billed in addition to the breeder by the practitioner.

**7 : In case of illness or accident** of the mare, her foal, a veterinarian is called by ESR staff to provide the care required by the emergency, as it is their responsibility to warn the breeder or his representative as soon as possible. He remains free to choose the practitioner. The costs incurred are the responsibility of the breeder. In the event that the breeder is not reachable and the vital prognosis is at stake, the practitioner and ESR are authorized to transport the animal to an equine veterinary clinic.

**IMPORTANT:** The broodmare is only admitted to the stud farm accompanied by this signed accommodation agreement and the required deposit bank transfer

**7 : MANDATORY PAYMENT AND SETTLEMENT OF INVOICES**

Must be in transfer before the mare arrival to ESR:

. to Vet Team for monitoring and insemination

- . €300 fresh semen of BLH stallion (wahoo)
- . €420 fresh or chilled semen of BLH stallion
- . €645 frozen BLH stallion
- . €530 chilled semen out of BLH catalog
- . €720 frozen semen out of BLH catalog

. to ESR for stable fees and/or foaling

- . €150 stable fees deposit € 690 foaling deposit.

**8 : RISK INHERENTS N THE REPRODUCTION AND GUARDING GARDIENNAGE**

Risks are inherent in the reproduction, guarding in particular during the trans-rectal gynecological examinations (mortality by rectal tear of 2.2 per 100,000 examinations), the inseminations, the foaling, the transport, field with congeners. The mare can lose weight during the food adaptation phase or during scorching heat. There is a risk of contagion, of accident when in contact with congeners. The seed may be unavailable at the desired time.

The breeder is informed that only mares and foals worth less than thirty thousand euros incl. Tax (30,000 € incl. Tax) each, semen of less than two thousand euros incl. Tax and embryos of less than five thousand euros are accepted. In the center. This means that if the owner entrusts his animals, semen and embryo to ESR and vet team, he formally and definitively acknowledges that his animals, semen and embryos do not have a value greater than these amounts during the duration of their stay. This has the consequence that in the event of a disaster occurring to these

Animals, semen and embryo whatever the cause, the responsibility of ESR or Vet Team both for veterinary acts, insemination acts and ancillary acts as well as guarding is limited to a maximum compensation of € 30,000 including tax per animal, € 2,000 for the entire amount of semen entrusted, € 5,000 per embryo. The owner and his entourage are fully responsible for the damage they suffer or cause to others during their presence in the center or in its annexes.

The owner or his representative, who declares himself authorized by the owner, claims to have been informed in clear terms and to have fully understood this agreement. He accepts it in full and in particular with regard to the value of the animal (s), seed (s) and embryo (s) entrusted. He knows that no guarantee has been given to him as to the expected result and that insemination in frozen or chilled semen reduces fertility. He certifies being authorized by the manager of the chosen stallion to use the seed. He settles all costs incurred with ESR and Vet Team during each departure of the animal. In the event of a dispute, the jurisdiction of the place of practice of European Stallions Resort e.a.r.l. and Vet Team are solely competent.
